Dear Secretary Tennant:

Please place within the Orders File of the State Register the attached Order revising the schedule of licensure fees for health care facilities licensed by the West Virginia Department of Health and Human Resources.

In accordance with W.Va. Code §§16-5B-4, 16-5C-6, 16-5D-6, and 16-5N-6, and W.Va. Code of State Rules § 69-7 and § 69-8, health facility licensure fees will be increased by 0.73%, which is the rate of growth to the Consumer Price Index over a period of 12 months from January 1, 2015 to December 31, 2015.

The new licensure fees will become effective: June 1, 2016.


